The Thumb Area Branch of the National Deer Association (“NDA”) is pleased to announce a benefit available exclusively to NDA **Premium or Life** members [if you are not one, become one by going to <https://deerassociation.com/join/>] interested in a limited cost share for selected habitat projects in Huron, Sanilac and/or Tuscola County(ies). The Thumb Area Branch of the NDA has agreed to provide up to a total of \$6,000 for this year’s program, with no more than \$200 going to any one Applicant and/or Property.

Requirements include:

1. **50% cost share** will only apply to purchase(s) (including related sales tax and handling fees) made in the spring of 2025 from the Conservation District(s) in Huron, Sanilac and/or Tuscola County(ies) of trees, shrubs, plants, grasses and/or related protective items (e.g., tree guards and/or mats) collectively referred to herein as “**SC Qualified Purchases**”; FOR THIS PROGRAM, SEEDS AS WELL AS ANYTHING ELSE NOT VISIBLE ABOVE GROUND AT THE TIME OF PLANTING ARE NOT CONSIDERED QUALIFIED PURCHASES AND NO REIMBURSEMENT WILL BE PAID FOR THEM;
2. **25% cost share** will apply to purchase(s) (including related sales tax and handling fees) made in the spring of 2025 **from source(s) other than the Conservation District(s) in Huron, Sanilac and/or Tuscola County(ies)** of trees, shrubs, plants, grasses and/or related protective items (e.g., tree guards and/or mats) and/or grass seeds (collectively referred to herein as “**Non-SC Qualified Purchases**” and all **SC Qualified Purchases** and all **Non-SC Qualified Purchases** collectively referred to herein as “**Qualified Purchases**”); FOR THIS PROGRAM, SEEDS AS WELL AS ANYTHING ELSE NOT VISIBLE ABOVE GROUND AT THE TIME OF PLANTING ARE NOT CONSIDERED QUALIFIED PURCHASES AND NO REIMBURSEMENT WILL BE PAID FOR THEM;
3. All **SC Qualified Purchases** and all **Non-SC Qualified Purchases** must be properly planted and/or properly utilized (collectively referred to as “**Plantings**”) in Huron, Sanilac and/or Tuscola County(ies) in the spring of 2025;
4. The person making the application (“**Applicant**”) **must be a NDA Premium or Life member [become a NDA Premium or Life member by going to <https://deerassociation.com/join/>]** during relative time periods (e.g., as of the time of all **Qualified Purchases**, all **Plantings**, **Application**, **Payment**, etc.);
5. All **Plantings** must be on real estate owned, directly or indirectly, by Applicant (“**Property**”) in such a manner that Applicant can, and does, grant representatives of the Thumb Area Branch of the NDA legal permission to enter onto the **Property**, preferably with Applicant, on a mutually agreeable date and time (on or before August 24, 2025), to inspect, and to take pictures for publication of, the **Plantings** and **Property**; and
6. **Application, with all required supporting documentation, proving that all of these requirements have been satisfied (e.g., proof of payment for the Qualified Purchases, etc.), must be timely submitted by email to [thumbareaqdma@gmail.com](mailto:thumbareaqdma@gmail.com) as soon as possible but in no event after May 2, 2025. The Application form is attached hereto and made a part hereof.**

After inspection of the **Plantings** of an acceptable **Application**, the approved **Applicant** will receive a check from the Thumb Area Branch of the NDA for the sum of:

- (a) up to one-half (1/2) of the price of the **SC Qualified Purchases**, plus
- (b) up to one-quarter (1/4) of the price of the **Non-SC Qualified Purchases**

up to a total of \$200.00, the maximum amount of the check from the Thumb Area Branch of the NDA. Again the maximum cost share is \$200 per Applicant (and/or Property). **Please note that if there are too many Applications, then the limited funds may be paid out on a first in time basis of those Applicants who have satisfied all of the requirements as determined by the Thumb Area Branch of the NDA in its sole and absolute unfettered discretion.**
